Adult social care · draft v9 · 34 quality statements → 24 topics

These are drafts. Built from CQC's DRAFT sector frameworks published 24 March 2026. CQC is piloting these over summer 2026, with implementation expected at the end of the year. CQC has published no official mapping — this crosswalk is Safe Workplace's interpretation of topic scope, not CQC's. We will send you the final version free when CQC publishes.

Start here: most of this is unchanged. Two quality statements change key question — they are flagged in red below. Rows marked Absorbed or Redistributed have no direct successor, so that evidence needs re-homing. Everything else is a label change.

What this means in practice

It is consolidation, not expansion. 34 quality statements become 24 topics. Fewer things to evidence, not more.

The five key questions have not moved. Safe, effective, caring, responsive and well-led have been constant since 2014, through every framework generation. Evidence organised around them carries across.

Scoring is being removed. CQC will judge each key question directly against published rating characteristics rather than aggregating scores. That means ambiguity in your evidence becomes ambiguity in the judgement — and a provider with complete, dated, owned evidence is in a stronger position than before, not a weaker one.
